Product Warranty

FUSION, INC.'s ("FUSION") lifetime product warranty for hardware starts on the date of purchase, and continues for as long as the original customer owns the

product. FUSION's limited product warranty for software starts on the date of purchase, and continues for a period of ninety (90) days thereafter. FUSION products repaired or replaced under warranty shall be subject to the product warranty remaining for the original products that are repaired or replaced.

Should a FUSION hardware product, or the media in which FUSION software is delivered, have defects in material or workmanship while covered under warranty, it will be repaired or replaced with the same or functionally equivalent product by FUSION, at its discretion, free of charge provided you: (1) return the failed product to a FUSION designated repair facility with shipping charge prepaid, and (2) provide FUSION with written proof of the original date of purchase, such as a dated purchase receipt. Repaired or replacement products will be returned to you with shipping charges prepaid. Prior to returning any defective product, the end customer or the reseller from whom the end customer originally purchased the product must obtain a Return Materials Authorization (RMA) number from FUSION. All defective products should be returned to FUSION with shipping charges prepaid. FUSION will not accept collect shipments. Replacement products may be refurbished or contain refurbished materials. If FUSION, by its sole determination, is unable to repair or replace the defective product, it will refund the purchase price of the product, less a reasonable usage charge.

This warranty does not apply if, in the sole judgment of FUSION, the product fails due to damage from shipment, handling, storage, accident, abuse or misuse, or if it has been installed, used or maintained in a manner not conforming to product manual instructions, has been modified in any way, or has had any serial number removed or defaced. Repair by anyone other than FUSION or an approved agent will void this warranty. The maximum liability of FUSION under this warranty is limited to the purchase price actually paid by the customer for the product covered by the warranty, regardless of the amount of any other direct or indirect damage suffered by the customer. FUSION makes no warranty that FUSION software will be error free or will operate without interruption. FUSION reserves the right to revise or update its products, software or documentation without notice. FUSION also reserves the right to change the terms of its limited product warranty at any time.

Except as specifically provided above or as required by law, the warranties and remedies stated above are exclusive and in lieu of all others, oral or written, express or implied. Any and all other warranties, including implied warranties of merchantability, fitness for a particular purpose and non-infringement of third party rights are expressly excluded. FUSION shall not under any circumstances be liable to any person for any special, incidental, indirect or consequential damages, including without limitation, damages resulting from use or malfunction of the products, loss of profits or revenues or costs of replacement goods, even if FUSION is informed in advance of the possibility of such damages. The maximum liability of FUSION under this warranty is limited to the purchase price actually paid by customer for the product covered by the warranty. Customer's purchase and usage of this product is expressly contingent upon the acceptance of the warranty terms above.
